



183 North Mobility Project



Project Update

The Central Texas Regional Mobility Authority (Mobility Authority) is pleased to announce that construction of the 183 North Mobility Project is on the horizon. Construction is scheduled to begin in early 2022 on the nine-mile stretch of US 183 between SH 45 North and MoPac. The 183 North Mobility Project aims to improve mobility, reduce congestion and provide more reliable travel times for transit and emergency responders along this portion of US 183.

To address issues on and off the roadway, the project includes the construction of two express lanes in each direction and the addition of a general-purpose lane to bring the number of non-tolled lanes to four in each direction. The project will construct an express lane direct connector between the new US 183 express lanes and the existing MoPac express lanes. The project also includes operational improvements to southbound MoPac, new shared use path connections, new sidewalks and cross-street connections for bicycles/pedestrians.

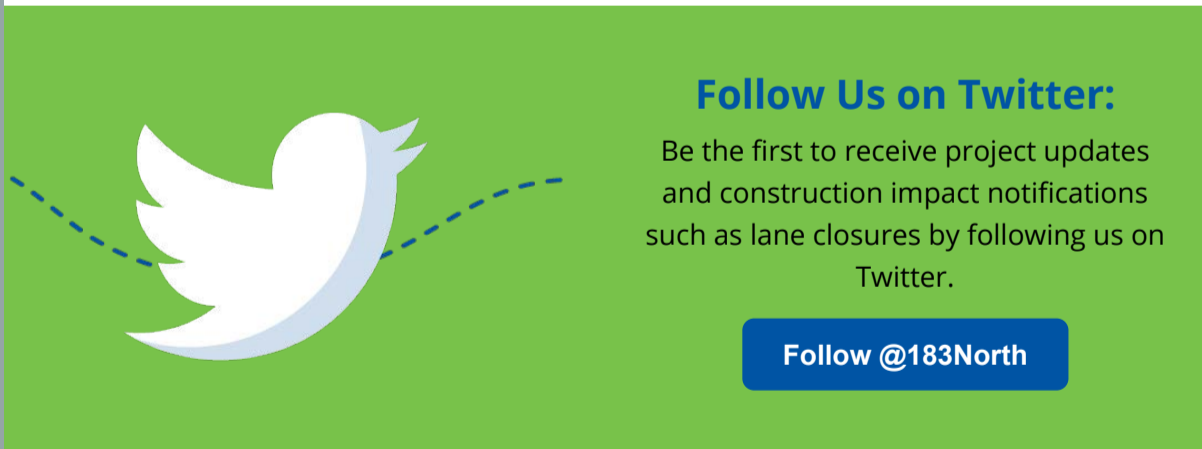
